The financial subsidies are approximately NT\$ 30,000,000 provided from the central government for improving road constructions, which cover constructions of traffic routes surrounding schools.

4: Over the past 12 months have there been any changes to your working groups/priority areas?

5: Please list at least three success stories from your program over the past 12 months? Provide details (e.g. what was the nature of the success, did it advance partnerships/relationships, ability to attract funds and what outcomes were achieved):

- 5.1 Integrate with subsidies from higher authorities to process the road safety program that includes four constructions: sidewalk paving constructions on Ming-De road; sewerage and paving constructions on Feng-Shih road; second bicycling route constructions; reconstructions of Touniu Recreational Sports Park due to Typhoon Morakot, so as to improve road safety for users.
- 5.2 Integrate with subsidies from higher authorities to process the road safety program and environment improvement constructions of bicycling routes and the extended roads thereof surrounding Shihkang school areas, so as to provide schoolchild safe routes to schools.
- 5.3 Apply subsidies from the township office to schools for promoting children and juvenile safety program, so as to improve playground equipment of the schools. Also, school corridor pillars are installed with bumper pads and “Walk, Don’t Run” warning signs to protect students’ safeties.

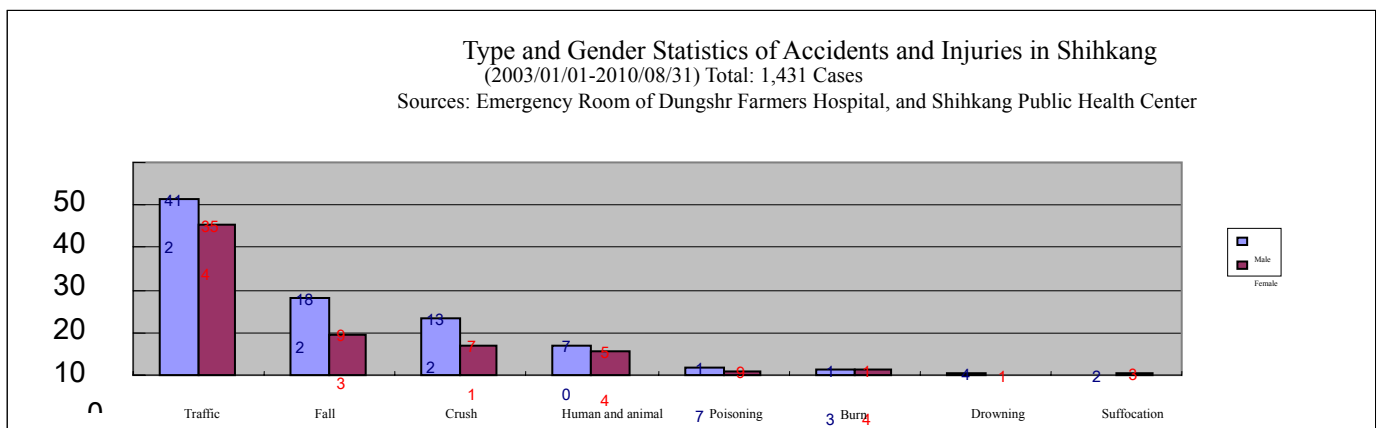
Criteria 4– Injury data

According to Shihkang accident and injury surveillance data, collected from 2003/01/01 to 2010/08/31, it shows statistics and analyses concerning eight major accidents and injuries in the past eight years. (Sources: Dungshr Farmers Hospital, as a subsidiary organization of Dungshr Farmers Association, and Shihkang Public Health Center)

The total injury cases in Shihkang were 1,431 and the top three are traffic, fall and crush injury, with a proportion of male 58% and female 42%. Therefore, our missions still focus on road constructions improvement, fall preventions for senior citizens, and crush injury prevention at work in this year.

- A. We welcomed visitors from Wenshan Community, Taipei City on May 19, and made arrangements for the visits, such as presentations of Shihkang and Wenshan SC programs; introductions of farming safety education classrooms, home safety programs, bicycling route improvements of Dongfeng Green Corridor in Shihkang section, and injury surveillance programs. Through exchanging experiences in community safety promotions, both Shihkang and Wenshan Communities work together as partners.
- B. We welcomed visitors from Xinyi Community, Taipei City on July 28, and made further arrangements for the visits, such as adding introductions of school safety programs of Shihkang Junior High School. Through the visit, we can examine our programs and establish a better interaction and learning.
- C. We welcomed visitors from Xiufeng Community, Taipei County on September 14, and made arrangements for the visits, such as presentations of Shihkang SC program; exhibitions of documentations in connection with assessment and accreditation, and introductions of home safety programs. We are glad to share our experiences to Xiufeng Community which would need more assistance in information collection and data compilation from this visit. Through the sharing, competences of both communities can be enhanced.
